## **WOODCUTTER REQUIREMENTS**

We are preparing for the Elder Services woodcutting program. To be a woodcutter for our program, the following will be expected of you.

- 1. Only tribal members are allowed to cut firewood.
- 2. Liability insurance is required on the vehicle you are using.
- 3. All permits required by Tribal Ordinance are responsibility of the woodcutter.
- 4. Council has ruled no logging equipment may be used obtaining or hauling firewood.
- 5. Only dry wood will be accepted.
- 6. No pine will be accepted.
- 7. Full cords otherwise specified. Wood must be dry, split, and stacked.
- 8. Do not have clients sign wood forms until the wood has been delivered! Their signature means they approved the order
- 9. Complaints will be verified for the protection of the applicant as well as the woodcutter.
- 10. If the woodcutter is found to be at fault, he/she will be given the opportunity to correct the mistake. If there are complaints where the woodcutter is found to be at fault he/she will be terminated for this firewood season.
- 11. Bring in wood order forms that are signed and completed.
- 12. Check cannot be processed without a completed W-9 form.
- 13. Checks will be processed the same day if wood order forms are turned in by 4PM.
- 14. Checks will be held for pickup at the Elder Services Office. Woodcutter must pick up check themselves unless written permission or prior arrangements are made. Woodcutter can request check to be mailed to them.

I agree and understand all of the above. I understand that I will be paid \$185.00 per cord of wood. I understand the \$275.00 is for cutting, splitting, stacking, loading and delivery to eligible Elder Services clients.
