## CSKT Tribal Member Proposed Regulation Changes March 1, 2025 through February 28, 2026

The Confederated Salish & Kootenai Tribes announces the availability of the March 1, 2025 to February 28, 2026 Ordinance 44D Hunting, Fishing and Recreation Regulations for CSKT Members proposed changes. The Tribal Council welcomes comments from the public on these proposed changes.

We ask that all comments be submitted via letter or email, no later than 5:30 on Monday, January 6<sup>th</sup>, 2025. There will be an in-person public comment period from 4:00-5:00pm on Monday, January 6<sup>th</sup>, 2025 at the CSKT Permit office, at 406 6<sup>th</sup> Avenue East, Polson, Montana 59860.

### 2025-2026 Ferry Basin Bull Elk

Bull: Hunting Season: September 1, **2025** through December 31, **2025**

Cow: Hunting Season: September 1, **2025** through January 31, **2026**

2025-2026 Gray Wolf

Northwest Hunting Zone:

Hunting ***and Trapping*** Seasons: September 1, **2025** through April 30, **2026**

Harvest Limit: Two wolves per hunter until a maximum of 10 wolves are filled, or until April 30, **2026**.

Mission Mountains and South Hunting Zones:

***Hunting Season: September 1, 2025 through April 30, 2026***

***Trapping Season:*** December 1, **2025** through March 15, **2026**

Harvest Limit: One wolf per hunter until a maximum of 5 wolves are filled, or until March 15, **2026**.

Harvest Limit: Two wolves per hunter until a maximum of 10 wolves are filled, or March 15, **2026**.

***NOTHING HAS FUNCTIONALLY CHANGED. Language is added only to clarify the restricted season in Mission and South zones are for trapping only***

Wolf Trapping Instruction Class Requirements:

Those courses will be provided at Noon on Tuesday August **26<sup>th</sup>, 2025** and Thursday August **28<sup>th</sup>, 2025** at the Division of Fish, Wildlife, Recreation, Conservation offices in Polson (406 6th Ave East).
