**BACKGROUND INFORMATION**

**Please Read Carefully and Thoroughly**

Your answers should include convictions resulting for a plea of nolo contendere (no contest), but omit: (1) traffic fines of \$ 300.00 or less, (2) any violation of law committed before your 16<sup>th</sup> birthday, (3) any violation of law committed before you 18<sup>th</sup> birthday if finally decided in juvenile court or under a Youth Offender Law, (4) any conviction set aside under the Federal Youth corrections Act or similar state law, and (5) any conviction whose record was expunged under Federal or State Law.

Section 231 of the Crime Control Act of 1990, Public Law 101-647, requires that employment applications for Federal child care positions have applicants sign a receipt of notice that a criminal record check will be conducted.

If you answer “yes” to any of the following questions use the additional space section at the end of this application to provide the date, explanation of the violation, disposition of the arrest or charge, place or occurrence and the name and address of the police department or court involved.
