DUTIES:

The Tribal Water Management Board will consist of five members which will consist of two members appointed by the Governor of the State of Montana, two chosen by the Tribes, and a fifth to be chosen by the other four appointees.

The appointees must be 18 years of age or older. A reservation resident which means does business within the Flathead Indian Reservation boundaries; Is domiciled within Flathead Reservation boundaries; or Owns and maintains a seasonal residence within Flathead Indian Reservation boundaries. Not an elected official, but can be an employee or contractor of the Tribes. Have the following education or experience in one or more of the following fields: Natural Resources Management, Public Administration, Agriculture, Engineering, Commerce or finance, Hydrology, Biological sciences, Water law, or Water policy.

Tribal Council policy adopted in March 2007 states:

"An employee of the Confederated Salish and Kootenai who is applying for a board or committee vacancy is required to submit along with the Letter of Interest, a letter signed by the immediate supervisor and the Department Head authorizing the employee to apply for and serve on the board or committee. Any Tribal employee serving on a board or committee that is not directly related to the position the person holds in the Tribal organization, is required to use leave or leave-without-pay to attend all meetings, participate in any activity associated with the board or committee, or for any travel related to the board or committee. Tribal employees are restricted to serving on no more than one (1) board at any time."
