Position is a Testing Designated Position within the definition of the CSKT Drug Free Workplace Policy effective January 1, 1998. The successful applicant, if not already employed by the Tribes must pass a pre-hire drug test and serve a mandatory six (6) month probationary period.

This position performs professional, managerial, administrative, and supervisory work in the planning, development, implementation, and evaluation of the Supplemental Food and Nutrition Program for Women, Infants and Children (WIC) and coordinates with the Public Health Division for breastfeeding counseling and support as well as prenatal/postpartum support.

WIC Supervisory Duties

- Maintains the program within the WIC Federal Regulations, State Plan and local agency contract. Prepares reports accordingly.
- Performs and participates in formal and informal program evaluation activities, including the Annual Education Plan review.
- Collaborates in the development, implementation and evaluation of long and short range priorities, goals, plans and programs for the WIC program in coordination with state and federal priorities, Tribal Council Resolutions, and Tribal Health strategic plan.
- Coordinates intern and shadowing opportunities for students, acts as a preceptor as applicable.
- Attends all required trainings or delegates to an appropriate WIC staff.
- Manages all aspects of the WIC program budget.

General WIC Duties

- Provides breastfeeding and general nutrition consultation and education services to individual participants or small groups.
- Determines participant eligibility in the WIC program.
- Interviews applicants, performs anthropometric/hemoglobin measurements, documentation and follow up.
- Assess, review and offer information to clients based on identified nutrition and health concerns/issues.
- Prepares and maintains confidential case records and completes participant certification reports.
- Develops care plans. Makes referrals to health/medical and social service agencies as appropriate.
- Assigns food packages within WIC state plan guidelines
- Coordinates and participates in community outreach activities, public relations, and community educational activities to promote health and the WIC program in an effort to increase participation numbers.
- Actively participates in and acts as a liaison with other community agencies and professionals in collaborative efforts to address community health priorities.
- Ensures that educational materials for clients and staff are current and provide accurate information.
- Maintain a clean and safe clinic environment per cleaning guidelines. Compliance with CSKT safety standards.
- Provide consistency of services and accessibility for clients.
