The Northern Cheyenne Tribe (NCT) is soliciting bids for feasibility study for Quality Assurance Program Improvement program QAPI Project Coordinator to provide Project Coordination Services for the Northern Cheyenne Tribal Board of Health (NCTBH) on the Northern Cheyenne Reservation in Lame Deer, MT for the Fiscal Year 26 (January 2026 – September 2026) for Board of Health Administrative Office.

**BACKGROUND**

Northern Cheyenne Tribal Board of Health is a multi-disciplinary team that provides Health Education, Health Promotion and Disease Prevention on the Northern Cheyenne Reservation. NCTBH works to advance the overall health and wellness of the Northern Cheyenne Nation by cultivating dedicated and healthy staff. Our mission is to improve health care access for our communities to eliminate the negative health disparities within the Northern Cheyenne Nation, by providing quality, comprehensive, culturally proficient health care services while promoting health lifestyles and health self-sufficiency.

**CONTENT OF THE PROPOSAL**

QAPI Project Coordinator will provide project coordination services for the NCTBH Board of Health Quality Assurance Program Improvement project.

The QAPI Project Coordinator will gather data for the QAPI Project such as Patient information, data regarding data consistent with the Feasibility study of assuming the Quality Assurance Program Improvement from the Indian Health Service. The work will consist of Short Term goals with regards to funding, Long term goals for Planning & Developing. process.

**INDIAN PREFERENCE.** The owner will factor Indian preference into the bid analysis process however, it will in no case be the sole deciding factor in awarding work. Evidence of eligibility for Indian preference must be submitted with the proposal. Responsible bids will be accepted from Non-Indian owned contractors. In evaluation of the bids, the Tribe may, within funding limitations, give preference in the amount of 5% above the lowest total bid, to qualified Indian owned firms.

**TERO.** Each contractor is **required to be certified by the Tribal Employment Rights Office (TERO)** in accordance with the Northern Cheyenne TERO Ordinance. The contractor is required to comply with the requirements of the Northern Cheyenne Tribal Employment Rights Office.
