******VACANCY ANNOUNCEMENT******

TITLE: Property Management Field Crew Member (1 or more contract positions)
LOCATION: Tribal Lands – Pablo, MT.
SALARY: \$18.89 to \$21.71 per hour
CLOSING DATE: MONDAY, May 18, 2026 at 5:30 p.m. (MST)

SPECIAL CONDITIONS:

This position is not a Testing Designated Position (TDP) within the definition of the CSKT Drug Testing policy. **The successful applicant, if not already employed by the Tribes must pass a pre-hire drug test and complete a mandatory six (6) month probationary period.**

This is a furlough able position; it is primarily responsible for physical labor tasks to be performed out of doors. The major duties and responsibilities include:

- Mow Tribal ground and maintain equipment
- Construction of new fence, repair of existing fences, and removal and proper disposal of old fence materials.
- Demolition of small structures and cleanup of Tribal lands.
- Other duties as assigned.
- The Crew member interacts daily with persons, organization and agencies outside of the Tribal Government particularly Trust Land users with potentially hostile situations. The crew member routinely acts as an intermediary to deliver and receive information on behalf of the Tribal Government, and Tribal Lands Department.
- The Crew Member works primarily out of doors. Outdoors work largely involves common hazards such as falling objects and weather extremes. The work mainly involves mowing, construction, repair and removal of fences, installation of other land improvements, and cleanup work on Tribal lands. The Crew Member will be required to use hand tools and routinely lift weights up to 60 pounds, hikes, climbs, kneels, stoops, crouches and walks long distances on uneven ground.

MINIMUM QUALIFICATIONS (AS REFLECTED ON TRIBAL EMPLOYMENT APPLICATION)

- High School diploma or equivalent required. Mowing & Fence construction experience preferred but not required.
- Working knowledge of mowing & fencing and construction.
- Ability to read and interpret maps
- Skilled with the use of hand tools and outdoor equipment

- Ability to follow instructions.
- Ability to interact positively with other employees.

Special Requirements

- Possession of a valid Montana Motor Vehicle Operator's license. Possession of a CDL is desirable.
